MOTION: To accept minutes from last month as presented, seconded, **VOTE: PASSED.**

OFFICER REPORTS:

Facilitator: Correnna N. (present) – In order for us to accomplish everything we need during these Area meetings, it is imperative that we do not have everyone speaking out of turn whenever they wish. TRUSTED SERVANT REPORTS:

Regional Committee Member: Marla M. (**present**) – Wisconsin Region Service Committee (WRSC) met on May 16 – 17, 2009 in Stevens Pointe, Wisconsin. **1) Regional Activities**: “Our Common Denominator” a black and white themed dance, will be August 22nd in Oshkosh, Wisconsin. This will also include speaker, auction, raffle, and cookout. The location will be Solutions Recovery Club Inc. Tickets are available in advance for \$8.00 from the RCM. The price includes a meal and dance. **2) PR**: Will be producing a new meeting list. Updates are needed back by June 20, 2009. **3) Budgets**: Literature budget was passed - \$1200.00 per year; Policy budget was passed - \$360.00 per year; & WSNAC Rep budget was passed - \$908.00 per year. **4) Elections**: Policy – John H., Literature – Nancy M., WRSO Pool – Shaw P., Public Relations – Brian nominated, WSNAC Rep even year – *Open*, Outreach – *Open*, and H&I – *Open*. **5) MOTIONS**: **A) [RCM2009-06-01-1]: From an AREA – To rescind the IP “For The Parent / Guardian” Intent** – it violates our Traditions (Tradition 6), discussion, **VOTE: FAILED.** **B) [RCM2009-06-02-1]: Question from Region**: How much should Region contribute financially for participants to attend Region? **Discussion** – *Relevant information*: As of right now, Regional position holders get \$50.00 to help pay for gas, hotel, food, etc. to attend Region leaving Regional position holders to fund the remainder of the cost themselves. *Observation*: Eventually, if there is an open position at Region because someone who is qualified to hold that position, but can not hold the position due to financially not being able to pay the extra to participate, then the newcomer will suffer! RRAGS spends on average \$358.00 every time we send our RCM and RCMA to Region. Financial security

should not be a factor in whether or not you can hold a Regional position. **Sub-MOTION:** To take back to groups - How much should Region contribute financially for participants to attend Region? **VOTE: PASSED.** **6) Sunday's Business:** Business resumed Sunday morning, but there were not enough RCMs to continue business for several hours! The quorum issue was discussed at length by those present. PR has funds in the amount of \$300.00 to attend the NRIADA Conference. If anyone knows of a conference, let PR know. An Area brought up an idea to form "Multi-Area Work Groups" where 2-3 adjacent Areas would get together and discuss common concerns and overlapping services. H&I has been floundering at the Regional level for several years. WRSC requests that all Area H&I Chairs available come to the next Region in Scenic Bluffs in July. Functions: Marla M. (present) – The RRAGS Picnic is NEXT Saturday June 13, 2009 at Aldeen Park in Rockford, Illinois. (*Outburst – YEA!*) Everyone who just said "YEA" better be there! Please come and join us. Meat and buns will be provided as well as a few vegetarian items. Bring a dish to pass and a car / truck load of people. Final preparations are being made for this event. Planning continues for the Spiritual Retreat. **MOTION:** [*F2009-06-01-1*] for \$400.00 for food and drink for the Spiritual Retreat. **VOTE: PASSED.** **MOTION:** [*F2009-06-02-1*] for \$50.00 for deposit for the Spiritual Retreat. **VOTE: PASSED.** Thankyou for allowing me to serve, Marla M.

Literature Review: Rich M. (present) – No report turned in! Took information back to Region that I received on the 2 literature pieces I received from World.

Hospitals & Institutions: Mike C. (present) – There is not much to report this month, except that - We are still in need of *men* and *women* to speak at the jail!!! Clean-time requirement is 2 years. You also need to be off paper and have an orientation meeting at the jail. We need men and women for PHASE in Belvidere, Illinois. The H&I Subcommittee has recommended that Bernard take over as Chair of the Subcommittee. He is very involved in H&I and I believe he will do a great job. These last 2 years have been a wonderful experience for me. I'm glad I was volunteered for this position. I received 11th Edition Basic Text from Freedom To Grow. 5 of these are going to Sojourn House and 2 are going to the N-Center. In loving service, Mike C.

Public Relations: Eric D. (present) **1) NA World Website:** The NA World website is completely up to date. I had to add A Way Out, It's Time To Make That Change II, and Monday Night Prime Time. I had to re-add almost every meeting on the schedule to get the codes corrected. From here on out it should be just a matter of monthly updates, so the tedious part is done. I deleted KISS and also deleted old Trusted Servant information. After elections today, I would appreciate it if any newly elected Trusted Servant who wants to have their contact information in the NAWS database, give me that information: address,

phone, e-mail, etc... Currently I am the sole contact for the RRAGS Area in the NAWs database. I brought a printout of the NAWs meetings and would like everyone to double check their meeting information. With all those changes, I could have made mistakes. **2) NA Way:** 2 groups – West Side Family and New Beginnings NA Way subscriptions are going to Linda's and Christian P's addresses respectively. All others come to the RRAGS Po Box. Could those GSRs please confirm that they want the NA Way sent to those members? If not, I can change it. **3) RRAGS Website:** The RRAGS website has been updated and is now correct. Please go to www.rragsna.org and check to see if your group's information is correct. **4) WRSC Website:** I asked the Wisconsin Region if I could directly modify the Regional website. They said no, but then invited me to send a service resume to be considered for a Regional Webservant position. I will be doing that, but haven't gotten to it yet. So unless I am selected to serve in that capacity, our meeting information at Region will still only be updated via my sending a spreadsheet. Thanks Eric D.

Policy & Procedure: Mark B. (present) – I would like to thank everyone for the opportunity that was given me to be of service to Narcotics Anonymous and RRAGS as Policy & Procedure Chair this last year. I have learned much about Policy and know more than I did when I was elected about procedure. I feel that there is a lot more that I need to learn about Policy & Procedure (especially procedure) to truly be an effective Policy & Procedure Chairperson. Again thanks. Now on to the regular stuff. Policy is completely updated and unless a policy motion passes today, ready for its next printing. Basic Policy encompasses 22 pages and 18 pages of position specific forms and additional information (phoneline guide, literature forms, minutes format, inventory format, etc). I got a sweet deal on ink and will print the Policy packets on my printer, and with a little ingenuity, Policy will for the most part be printed on both sides. Doing so, we only use 24 pages for a complete Policy packet instead of 40 pages, or the 54 pages last year! Also, the forms and additional information that is position specific will only be printed and included in the specific policy packet for said position. Example #1 – GSRs will receive basic policy, literature order forms, and 6 copies of the GSR report form; Example #2 – Treasurer will receive basic policy, 6 copies Trusted Servant report form, working reserve form, and service Committee Inventory format pages; Example #3 – Public Relations will receive basic policy, literature stockpile quantities, 6 copies Subcommittee report form, working reserve form, and 12 Step volunteer & phoneline guidelines and instructions pages. The estimated cost to print this edition of Policy is going to be between \$40 and \$48. Additionally, I thought it would be nice for the GSRs and Trusted Servants of RRAGS to have their copies of Policy in a portfolio. Who knows, they might even look at Policy more often; the GSRs can give their copy to the next GSR in line etc. They can be reused and also have 2 pockets. Cost of the portfolios minus the worklife rewards I have amassed is \$11.00, well within my working reserve. I am asking for reimbursement and have turned a receipt in to the Treasurer. Keep in mind that anyone may request a copy of Policy, and it is available for downloading from the website www.rragsna.org. I will get the new revised copy to Digital Information so it can be posted. Any GSR who was not here last month when the 2009 / 2010 meeting rotation was passed can see me for a copy during the 10 minute break. As a reminder, the July 5th ASC meeting has been moved to June 28th so everyone can enjoy the 4th of July weekend; also that the September 6th ASC meeting has been moved to August 30th so everyone can enjoy the Labor Day weekend.

Main MOTION: [PP2009-06-01-1] To change the April 04, 2010 ASC at Reality Check to Sunday March 28, 2010 due to Easter being on April 04, 2010. **VOTE: PASSED.** *Thank you for allowing me to be of service to Narcotics Anonymous, Mark B. PEACE*

Convention Committee: Eric B. (present) – We met Friday. It was a good productive meeting, although we had a few absences. A few Subcommittee notes: **1)** Registration will meet Saturday June 20th from 5 – 7 pm. **2)** Hotels & Hospitality has already met with last years facility and is working on other facilities. **3)** Both Program and Arts & Graphics will meet at 90 IN 90 the 2nd and 4th Sunday from

5 – 7 pm. **4)** The Convention Committee has approved meeting at the Rockford Public Library for a donation based on the 7th Tradition collected at the Convention Committee meeting. We have not as yet secured the location for the next Convention Committee meeting, so we will meet next on Friday June 26th at Freedom To Grow. Subcommittees start @ 7 pm and Convention Committee Starts @ 8 pm. In loving service, Eric B. **MOTION:** [CC2009-06-01-1] For Convention Chairperson to take inventory of all items and archives received from all Convention Subcommittees and turn the inventory over to the next Chairperson. **VOTE: PASSED.**

Digital Information: Eric B. (**present**) – **1)** Not much to report. I have been behind on the updates to the website. My time was limited by work obligations this past month. It has been a pleasure developing and maintaining the website for RRAGS. It has been an excellent communications tool. We really only have 3 active members on a regular basis. We have for the most part, divided responsibilities. Having consulted the active members, it is the recommendation of this Subcommittee for Rich M. to be nominated for Digital Information for the next cycle. **2)** I will continue to serve as web-monkey under whoever is elected and offer my experience tom their direction. In loving Service, Eric B.

Outreach: Mary W. (**absent with notice**) – *Report given by Chris K.* Not much going on this month. Very soon there will be a Spanish speaking meeting. We have a Chairperson, looking for a meeting place. In loving service, Mary W.

Archive Ad-Hoc: Chris K. (**present**) – We are looking for more people to help with Archive. Moving forward. Chris K.

RRAGS Expense Ad-Hoc: Jennifer K. (**present**) – The Ad-Hoc Subcommittee met over the course of 8 weeks and there was anywhere from 6 – 11 in attendance. Recommendations coming out of this Ad-Hoc subcommittee are as follows: **1) To Literature Stockpile:** We recommend that they round literature in the sales process. Perhaps rounding up the literature slightly may offset the costs of what is donated to Hospitals & Institutions and Public Relations. **2) To Literature Stockpile:** We recommend that Literature Stockpile have groups order and pay for their literature in advance. In other words, for example...the groups will place and pay for their order in May, Literature Stockpile will then order it, and the groups will pick it up in June. This will reduce the amount of literature that must be kept on hand to fulfill group orders. **3) To Public Relations:** We recommend that although the Helpline was determined to not be a duplicate service, it is still a fairly sizable expense. We recommend that Public Relations continue to look at alternate options for the Helpline. There may be other ways to lower the Helpline expenses and these should be analyzed. **4) To Public Relations:** We recommend that a new Subcommittee be formed possibly called “Membership Services” to bridge the gap between ASC and the groups. Responsibilities of this Subcommittee would be to have its members visit groups every month to find out what the groups need from the ASC. This Subcommittee would also schedule workshops and other events hosted by the individual groups to promote group unity. **5) To Individual Groups:** We recommend that when groups are planning events or are adding new meetings, that they be conscious and courteous of other group’s schedules. If individual groups could increase their attendance at their meetings and events, it could increase their ability to become fully self-supporting. Motions coming out of this Ad-Hoc Subcommittee are as follows:

1) Main MOTION: [REA-H2009-06-01-1] That AREA and it’s Subcommittees become budget based as opposed to Prudent Reserve based. Each Committee and Subcommittee would be responsible to analyze how much they spend annually and break that down into a monthly amount. **Intent:** All of the reporting Subcommittees reported that their Prudent Reserve amount is never consumed on a monthly basis. This would free up the ASC to donate to WRSC and NAWS as well as provide a simpler accounting method. Each Committee and Subcommittee has reported that they could work within a

monthly budget. Discussion - pros and cons; **Sub MOTION:** To send back to groups, Seconded, **VOTE: PASSED.** **2) Main MOTION:** [REA-H2009-06-02-1] That Functions (Subcommittee) lowers their Prudent Reserve from \$750.00 per month to \$300.00 per month with a \$500.00 cap per event. **Intent:** Currently the monthly Prudent Reserve is never needed and the events have been under \$750.00, so it makes sense to lower the Prudent Reserve amount. This will free up ASC to donate to WRSC and NAWS as it will be easier for ASC Prudent Reserve to be met. **Sub MOTION:** To table until resolution of motion #1 [REA-H2009-06-01-1], Seconded, **VOTE: PASSED.**

3) Main MOTION: [REA-H2009-06-03-1] That Convention Committee split their annual donation to ASC into 12 equal monthly installments. **Intent:** To help ASC function in a more prudent manner. As it is now, after Convention makes their donation the first portion of the funds are used to bring ASC current on the Prudent Reserve. The remaining portion is sent on to WRSC and NAWS. As ASC runs short on funds throughout the year, it must dip into the Prudent Reserve. If Convention Committee donates monthly to ASC, this will allow ASC to have funds to donate to WRSC and NAWS on a monthly or semi-monthly basis. As it stands now, everything above Prudent Reserve must be donated. When we donate the large amount all at once, we then fall short the rest of the year and we are unable to donate the rest of the year. Discussion – Pros and cons. **Sub MOTION:** To send back to groups, Seconded, **VOTE: PASSED.**

Ten.....Minute.....Break

Meeting reconvened with the Facilitator asking for a moment of silence.

Open Forum Discussion: 15 Minutes – Co-Facilitator opened: Topics: 1) An increase of 15% on literature would bring in an extra \$100.00 per month (\$1200.00 per year) effectively paying for both H&I’s and PR’s literature. **2)** Note the back of the newsletter this month – the NA Picnic, don’t leave the picnic table empty! **3)** With elections, after the person leaves the room, why is there discussion? **A:** If I or you had a concern or a question and wanted to remain anonymous, it’s the time to bring it forward and if the person needs to come back in to answer said question or concern, it can be done with the Facilitator asking. **4)** Term limits – 2 years.

Co-Facilitator closed Open Forum.

Literature Stockpile: Scott A. – This month’s group sales - \$914.70; Reorder - \$1,025.40; No H&I or PR order this month. Thanks for letting me be of service, Scott A.

Literature Stockpile Alternate: Yvette M. – Nothing else to report.

OLD BUSINESS:

Main MOTION: [NB2009-03-01-1] That Area do away with the live service and local phone number and revert back to the “800” number and automated answering service provided for us by Regional services. **Intent:** If the Area expenses exceed the Area’s 7th Tradition donations from groups, then we need to reduce expenses. This will be more fiscally responsible and prudent with NA funds.

Sub-MOTION: To remove from table. **Intent:** Answers provided by the RRAGS Expense Ad-Hoc cleared the motion – see Ad-Hoc report. Seconded, **VOTE: PASSED.**

MOTION: [OB2009-06-01-1] To extend business until concluded or until it interferes with next meeting, Seconded, **VOTE: PASSED.**

RRAGS ELECTIONS: All positions open. (16 GSRs voting)
Facilitator asked that everyone remain seated and no whispering!

1) **Facilitator:** Nominee Correnna N. accepts. **NOTE:** *Facilitator turned the meeting over to the Co-Facilitator.* Correnna N. stated qualifications; Questions or concerns were asked; nominee left room; additional concerns. **VOTE:** Correnna N. elected.

NOTE: *Meeting was turned back over to the Facilitator.*

2) **Co – Facilitator:** No nominees accepted. **OPEN Position!**

3) **Treasurer:** Nominee Debbie H. accepts. Debbie H. stated qualifications; questions or concerns were asked; nominee left room; additional concerns. **VOTE:** Debbie H. elected.

4) **Alternate Treasurer:** No nominees accepted. **OPEN Position!**

5) **Secretary:** Nominee Jennifer K. accepts. Jennifer K. stated qualifications; questions or concerns were asked; nominee left room; additional concerns. **VOTE:** Jennifer K. elected.

6) **Alternate Secretary:** Nominees Mark R. and Kasey D. accept. Both Mark R. and Kasey D. stated qualifications; questions or concerns were asked; nominees left room; additional concerns.

VOTE: Kasey D. elected.

7) **Regional Committee Member:** Nominee Marla M. accepts. Marla M. stated qualifications; questions or concerns were asked; nominee left room; additional concerns. **VOTE:** Marla M. elected.

8) **Alternate Regional Committee Member:** Nominee Nancy M. accepts. Nancy M. stated qualifications; questions or concerns were asked; nominee left room; additional concerns.

VOTE: Nancy M. elected.

9) **Literature Stockpile:** Nominees Yvette M. & Scott A. accept. Yvette M. withdrew. Scott A. stated qualifications; questions or concerns were asked; nominee left room; additional concerns.

VOTE: Scott A. elected.

10) **Alternate Literature Stockpile:** Nominee Yvette M. accepts. Yvette M. stated qualifications; questions or concerns were asked; nominee left room; additional concerns. **VOTE:** Yvette M. elected.
